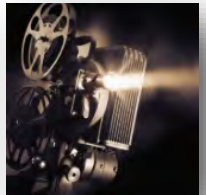


Mudslide: January 23 from 1:00-3:30 pm: Cost \$48: Due Jan 5

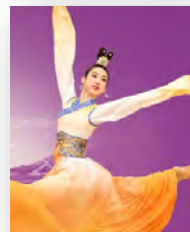

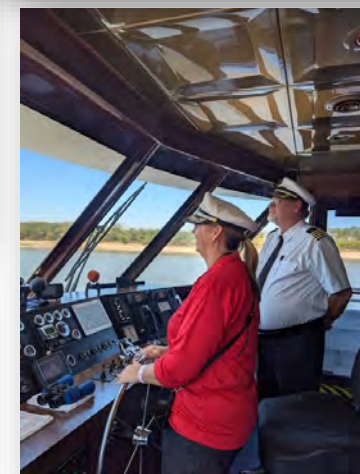

It's also easier to get autographs! With a maximum capacity of under 8,000 people, everyone's seat is close to the field. A lunch voucher will be included at the ballpark.

Tonight we will have free time in **West Palm Beach** at **CityPlace**, an open-air plaza that brings old-world architecture, beautiful fountains, and sidewalk cafes together to create an atmosphere strikingly reminiscent of a European town center. With more than 20 restaurants from which to choose, you'll find dining options for every taste and have time for some shopping as well.

Wednesday, March 18 (Breakfast, Dinner)

Enjoy breakfast at your leisure before we depart for the **Henry Morrison Flagler Museum**. This is the former home of Henry Flagler, the founder of the Standard Oil Company, who was responsible for much of Florida's development as a state. We'll take a self-guided walking tour of this meticulously restored mansion, which now houses a museum that includes many of the original furnishings and an art collection.

For our main event of the day we'll head to **Roger Dean Stadium**, the spring-training home of the Miami Marlins and the St. Louis Cardinals, where we take our seats for another exciting **Cardinals home game vs. the Houston Astros**. Concession stands feature great food options and hometown specialties from each team's city, such as Toasted Ravioli with marinara sauce and Gator Bites. Ballpark hot dogs are always a favorite, but it's the infamous "Chicago Cubs Hater Dog" with diced onions, tomatoes, neon relish, celery salt, sport peppers & pickle spear that draws the most attention in this park.

Later this evening, we will enjoy another group dinner together.

Thursday, March 19 (Breakfast)

We'll enjoy breakfast before making our way south to **Miami** to visit **Vizcaya Museum and Gardens**, a breathtaking Gilded Age estate on Biscayne Bay that was the winter home for industrialist James Deering. This Italian Renaissance-style villa is surrounded by ten acres of formal gardens that feature elaborate fountains and sculptures. Immerse yourself in Vizcaya's natural beauty, connect with Miami's past, and admire the extensive art collection of this National Historic Landmark.

After time to get lunch, we embark on a 90-minute **sightseeing cruise** along **Biscayne Bay**. Marvel at the spectacular coastal views, including the beautiful downtown Miami skyline, the Port of Miami, Fisher Island, Miami Beach, and "Millionaire's Row" - the residences of the rich and famous.

Afterward, we'll head to the airport for our flight home, ready to cheer on the St. Louis Cardinals all summer long!
